Heather Stuart, FRSC

Dr. Heather Stuart, MA (Sociology, University of Western Ontario), PhD (Epidemiology, University of Calgary) is a Full Professor in the Departments of Public Health Sciences, Psychiatry, and the School of Rehabilitation Therapy at Queen's University. She also holds the Bell Canada Mental Health and Anti-stigma Research Chair at Queen's. Dr. Stuart is also the Senior Consultant to the Mental Health Commission of Canada's Opening Minds, Anti-stigma initiative and the past Chair of the World Psychiatric Association's Stigma and Mental Health Scientific Section. She is a Fellow of the Royal Society of Canada and a recipient of the Order of Canada. Dr. Stuart's research focuses on mental health services evaluation with a specific focus on the destigmatization of mental illnesses. She has contributed to the peer reviewed scientific literature in the areas of mental health needs assessments; suicide and suicide prevention; stigma and stigma reduction; and workplace mental health and is the co-author of several books. Her most recent books deal with anti-stigma programming and human rights legislation.



John McGarry, FRSC

Dr. John McGarry is the Sir Edward Peacock Professor of Political Studies and Canada Research Chair in the Department of Political Studies, Queen's University. He has authored, co-authored, and edited fourteen books and over 80 journal articles and book chapters. His work has had an important public policy dimension and impact. He has testified as an expert witness in the US Congress and participated in briefings of the UN Security Council. In 2008, McGarry was appointed as the first ever "Senior Advisor on Power-Sharing" to the United Nations' Mediation Support Unit. He is currently the Senior Advisor on Governance and Power-Sharing in the UN backed negotiations in Cyprus. He has advised on a range of conflicts around the world, including Iraq, Yemen, Philippines, Kenya and Western Sahara.





Jamie Benidickson, FRSC

Jamie Benidickson teaches Environmental Law and Legal History at the Faculty of Law, University of Ottawa. His publications include *The Culture of Flushing: A Social and Legal History of Sewage* (UBC Press 2007) and *Levelling the Lake: Transboundary Resource Management in the Lake of the Woods Watershed* (UBC Press 2019). In addition to these academic interests, Jamie has been actively involved in the public policy process through his work with a number of royal commissions and inquiries, including the Royal Commission on Economic Union and Development Prospects for Canada and the Walkerton inquiry. He has also held several administrative positions with professional and academic organizations and served from 2004 to 2016 as Director of the IUCN Academy of Environmental Law whose international Secretariat was located at the University of Ottawa.



Joan Schwartz, FRSC

Dr. Joan M. Schwartz is Professor and Head, Department of Art History and Art Conservation at Queen's University, Kingston, Canada, where she is cross-appointed to the Department of Geography and Planning. She is also an Adjunct Research Professor in the Department of History at Carleton University, Ottawa. She holds a B.A (Hons) from the University of Toronto (1973), an MA from the University of British Columbia (1977), and a PhD from Queen's (1998). A specialist in photography acquisition and research at the National Archives of Canada for more than two decades prior to her faculty appointment in 2003, she is an elected Fellow of the Royal Society of Canada, the Royal Canadian Geographical Society, and the Society of American Archivists.
